

**On Tour With Pearl Jam
National Contest
Official Rules**

These Contest rules are specific to the above Contest conducted by the Entercom Operations, Inc. (the “**Contest Administrator**”) and its affiliated companies and radio stations listed on Attachment A at the end of these rules (each, a “**Participating Station**” and collectively, the “**Participating Stations**”). A copy of these specific Contest rules is available at each of the Participating Stations’ studios during regular business hours and on the contest rules page of each of the Participating Stations’ websites. A complete list of studio addresses and websites for the Participating Stations are listed on Attachment A.

Notwithstanding anything to the contrary in each Participating Stations’ individual general contest rules, these official Contest rules govern this particular Contest in the event of any conflict.

Who Can Enter

1. Winner(s) must be eighteen (18) years of age or older and be a legal US citizen of any one of the forty-eight (48) contiguous states as of the date of entry to enter and/or win this Contest.
2. Employees, officers, and directors of Entercom Operations, Inc., and their respective parent entities, subsidiaries, affiliated companies and advertising and promotion agencies at any time during the applicable Contest period and the immediate family and other household members (i.e., spouses, parents, grandparents, children, grandchildren, roommates, housemates, significant others, partners, siblings (half and full) and the steps of each of the foregoing) of each of the above are NOT eligible to enter and/or to win this Contest.

How to Enter

3. No purchase or payment of any kind is necessary to enter or win the “On Tour With Pearl Jam National Contest” (the “**Contest**”).
4. As part of the entry process, Entrants may be provided with an opportunity to opt-in to receive solicitations from, and/or to become a member/participate in clubs of (*i.e., email clubs, text clubs, and rewards programs*), the Contest Administrator and/or Participating Stations, Sponsors, or Prize Providers; provided, however, agreeing to receive such solicitations and/or accepting such membership is not a condition of entry into this Contest and will not increase your chances of winning.
5. For listeners of all Participating Stations (*as listed on Attachment A to these rules*) and **RADIO.COM** enter online beginning January 22, 2020 at approximately 12:00am (ET) and ending on January 28, 2020 at approximately 12:00pm (ET), visit one of the websites listed on Attachment A, click on the “Contests” button, and then click on the “On Tour With Pearl Jam” link, completely fill out the online entry form with your name, mailing address, city, state, zip code, phone number, email address, and click the submit button. Entrants will also be provided with an opportunity to opt-in for membership/participation in Station and sponsor email clubs as part of the entry process, but accepting such membership and/or agreeing to receive emails is not a condition of entry into this Contest.
6. Each individual who meets all applicable eligibility requirements set forth herein and who successfully completes the process of entering this Contest by means of the method described above shall be deemed an “**Entrant**”. Only one (1) entry per Entrant email address.
7. Entrants in this Contest may not violate any federal, state or local laws and may not harm or endanger themselves or other persons or property. If the Contest Administrator deems that any Entrant may have created a public hazard, cheated, engaged in improper activity, caused interference with or destruction of property and/or utilized public safety resources, such Entrant may be disqualified in Contest Administrators’ sole discretion.

How to Win

8. On or about January 29, 2020, the Contest Administrator will select one (1) **“Winner”** of the Contest, subject to verification of eligibility and compliance with these Contest rules, in a random drawing of all eligible online entries received. All decisions by the Contest Administrator in this Contest are final and may not be appealed under any circumstances.
9. The potential Winner will be notified within forty-eight (48) hours at the phone number and/or email address such Entrant provided when completing their online entry to this Contest. Potential Winner must be back in contact with Contest Administrator within twenty four (24) hours of Contest Administrator’s initial contact. If potential Winner does not contact the Contest Administrator within twenty four (24) hours by telephone or email, Prize will be forfeited and the Contest Administrator has the right, but not the obligation, in its sole discretion, to select an alternate Winner in a random drawing of all remaining eligible online entries received.

Prize(s)

10. The one (1) verified Winner will receive the following **“Prize”** consisting of three (3) **“Trips”**:
 - a. **“Trip 1”** includes the following
 - i. Coach airfare for the Winner and one (1) guest (age 18 or older) (the **“Trip 1 Guest”**) to a New York City, NY area airport from a commercial airport within ninety (90) miles of the Winner’s residence, departing on March 29, 2020.
 - ii. Two (2) or three (3) nights hotel accommodations (one (1) room, standard double occupancy) in a New York City, NY area hotel, checking in on March 29, 2020 and checking out on March 31, 2020 or April 1, 2020 (exact dates TBD by the Contest Administrator).
 - iii. Two (2) tickets to see Pearl Jam on March 30, 2020 at Madison Square Garden (4 Pennsylvania Plaza, New York, NY 10001).
 - iv. Coach airfare for the Winner and Trip 1 Guest from a New York City, NY area airport to Nashville, TN on March 31, 2020 or April 1, 2020 (exact dates TBD by the Contest Administrator).
 - v. Two (2) or three (3) nights hotel accommodations (one (1) room, standard double occupancy) in a Nashville, TN area hotel, checking in on March 31, 2020 or April 1, 2020 and checking out on April 3, 2020 (exact dates TBD by the Contest Administrator).
 - vi. Two (2) tickets to see Pearl Jam on April 2, 2020 at Bridgestone Arena (501 Broadway, Nashville, TN 37203).
 - vii. Coach airfare for the Winner and Trip 1 Guest from Nashville, TN to a commercial airport within ninety (90) miles of the Winner’s residence departing on April 3, 2020.
 - viii. All specific airports, airlines, flights, and hotels are to be determined in the sole discretion of the Contest Administrator and are based on availability.
 - b. **“Trip 2”** includes the following:
 - i. Coach airfare for the Winner and one (1) guest (age 18 or older) (the **“Trip 2 Guest”**) to a Denver, CO area airport from a commercial airport within ninety (90) miles of the Winner’s residence, departing on April 8, 2020.
 - ii. Two (2) nights hotel accommodations (one (1) room, standard double occupancy) in a Denver, CO area hotel, checking in on April 8, 2020 and checking out on April 10, 2020.
 - iii. Two (2) tickets to see Pearl Jam on April 9, 2020 at Pepsi Center (1000 Chopper Cir, Denver, CO 80204).
 - iv. Coach airfare for the Winner and Trip 2 Guest from a Denver, CO area airport to from a commercial airport within ninety (90) miles of the Winner’s residence, departing on April 10, 2020.
 - v. All specific airports, airlines, flights, and hotels are to be determined in the sole discretion of the Contest Administrator and are based on availability.
 - c. **“Trip 3”** includes the following:
 - i. Coach airfare for the Winner and one (1) guest (age 18 or older) (the **“Trip 3 Guest”**) to a Los Angeles, CA area airport from a commercial airport within ninety (90) miles of the Winner’s, departing on April 15, 2020.
 - ii. Two (2) nights hotel accommodations (one (1) room, standard double occupancy) in a Los Angeles area hotel, checking in on April 15, 2020 and checking out on April 17, 2020.
 - iii. Two (2) tickets to see Pearl Jam on April 16, 2020 at The Forum (3900 W Manchester Blvd, Inglewood, CA 90305).
 - iv. Coach airfare for the Winner and Trip 3 Guest from a Los Angeles, CA area airport to a San Francisco/Oakland, CA area airport, departing on April 17, 2020.

- v. Two (2) nights hotel accommodations (one (1) room, standard double occupancy) in a San Francisco/Oakland, CA area hotel checking in on April 17, 2020 and checking out on April 19, 2020.
 - vi. Two (2) tickets to see Pearl Jam on April 18, 2020 at the Oakland Arena (7000 Coliseum Way, Oakland, CA 94621).
 - vii. Coach airfare for the Winner and Trip 3 Guest from a San Francisco/Oakland, CA area airport to a commercial airport within ninety (90) miles of the Winner's residence, departing on April 19, 2020.
 - viii. All specific airports, airlines, flights, and hotels are to be determined in the sole discretion of the Contest Administrator and are based on availability.
- d. A backstage tour for two (2) people at one (1) of the five (5) shows above (show determined in the sole discretion of the Contest Administrator).
 - e. A Pearl Jam tour merchandise prize pack.
 - f. The Approximate Retail Value of the Prize is up to \$10,000.00.
 - g. Prize is courtesy of Republic Records / Universal Music Group.
- 11. The Winner's Trip 1 Guest, Trip 2 Guest, and Trip 3 Guest must be eighteen (18) years of age or older. The Winner may choose to have three (3) different guests (one (1) per Trip) or the same guest on each Trip.**
- 12. The Winner MAY opt out of any of the three (3) Trips, but must let the Contest Administrator know if they want to opt out of any trips no later than 5:00pm (ET) on March 8, 2020.**
- 13. The Winner and his or her guest must travel on the same itinerary. Once the reservations are made, no changes may be made by a Winner (including, without limitation, any changes in traveling companions). PLEASE BE ADVISED THAT STATIONS MAY NOT RECEIVE TRAVEL DOCUMENTS UNTIL JUST A DAY OR SO BEFORE THE DEPARTURE DATE AND WILL NOTIFY WINNER AS SOON AS THE DOCUMENTS HAVE ARRIVED AND DELIVER SUCH DOCUMENTS TO THE WINNER VIA THE EMAIL ADDRESS DESIGNATED BY WINNER AT THE TIME SUCH WINNER PROVIDES AND COMPLETES ALL DOCUMENTATION BY PARTICIPATING STATIONS. IT IS THE WINNER'S SOLE RESPONSIBILITY TO ENSURE THAT HE/SHE CAN PICK UP SUCH MATERIALS, EVEN ON LAST-MINUTE NOTICE. IN ADDITION, SUCH WINNER AND THEIR GUEST ARE SOLELY RESPONSIBLE FOR OBTAINING ANY TRAVEL DOCUMENTS THAT MAY BE REQUIRED. Reservations are non-transferable and once booked and confirmed may not be rescheduled. Winner and their guest will be solely responsible for all ground transportation, for the purchase of any items of a purely personal nature, for the payment of any incidental expenses, and for the payment of any taxes, charges, and/or fees. WINNER MAY BE REQUIRED TO PROVIDE A VALID CREDIT CARD TO CHECK INTO THE HOTEL AND TO COVER INCIDENTAL EXPENSES. Winner will be solely responsible for all ground transportation and for the pre-payment of any applicable taxes or airport, baggage, or government fees or charges.**
- 15. Contest Administrator is not responsible if a Winner and/or his/her guests are unable to meet such celebrity or participate in the associated activity if the celebrity determines this is not allowable for any reason or fails to appear/participate for any reason, including without limitation any illness, act of god, scheduling conflict or any other reason, Contest Administrator is not responsible for such portion of the prize, which has no monetary value, and no alternate prize will be awarded and the event/activity will not be rescheduled. In the event that Contest Administrator elects, at its sole discretion, to attempt to reschedule any such event/activity or offer an alternative prize, Contest Administrator will have no obligation whatsoever to offer any other alternate prize if such attempt to reschedule or other offer is not accepted by or utilized by Winner for any reason whatsoever.**

16. Contest Administrator reserves the right to substitute ground transportation for airfare if the Winner resides within 100 miles of New York City, NY, Nashville, TN, Denver, CO, Los Angeles, CA, or Oakland, CA, and any difference in value will not be awarded.

Sponsor(s)

17. The sponsors of this Contest are Entercom Operations, Inc., and Republic Records / Universal Music Group.

Other Rules Specific to This Contest

18. Odds of winning the Prize depend on the number of entries received.

19. Entercom Operations, Inc. is conducting the Contest concurrently and simultaneously on several Participating Station that are located in various States and their respective time zones. Entrants not located within the referenced time zone, must factor in the time difference in determining the dates and times stated herein. Company may add or remove Participating Stations or change call letters of any Participating Station at any time during the Contest as announced on the affected station. Station participation in this Contest during the Contest dates may vary from day to day as announced on air of the affected Participating Station, and as listed as amended in Attachment A and as noted in any applicable addendum. Station will announce participation.

20. Participating Stations may individually refer to this national Contest in varying ways depending on particular station's format and what it determines to sound most appealing to its particular audience (e.g., On Tour With Pearl Jam, Fly Away to see Pearl Jam, etc...) However, the Contest is one national Contest made up of many Participating Stations.

21. Station may use cookies and/or collect IP addresses (an IP address is a number that can uniquely identify a specific computer or other network device on the internet) for the purpose of implementing or exercising its rights or obligations under the Contest rules, for information purposes, identifying your location (including, without limitation, to re-direct you to the appropriate geographic website, if applicable) or for any other lawful purpose in accordance with Station's privacy policy (available from a link at the bottom of the Station's web site home page, which is listed below in Attachment A).

22. Information collected by Stations in connection with entering or otherwise participating in this Contest may be used in accordance with a particular Station's privacy policy (available from a link at the bottom of a Participating Station's website home page, which is listed below in Attachment A).

23. Complete Contest rules are available at a Participating Station's studios as listed on Attachment A during normal business hours or go online at a Participating Station's website as listed on Attachment A.
